FHMD Board Meeting

The next Falcon Highlands Metropolitan District Board Meeting will be held at 5:30PM, on August 12th, 2019, at the Falcon Fire Station #3 on Highway 24 & Old Meridian Road. Residents and Property Owners are encouraged to attend.

Water Operations & Park Maintenance

Falcon Highlands Metro District signed an Inter-Governmental Agreement (IGA) with Woodmen Hills Metro District to perform O&M of our Water Operations. Woodmen Hills has the equipment, staff and expertise for efficient and effective operations. The District previously employed one operator to manage District infrastructure, as well as park and landscape maintenance. Over the last few years the District has had failures and infrastructure issues that were preventable. As of June 15, Woodmen Hills took over operations of our Water Plant and their Parks & Recreation Department will soon take over maintenance of the park and common area landscaping. Woodmen Hills also provides this service on a Time and Materials agreement and the efficiencies in their operations promise to save our community on operating cost(s). Falcon Highlands Metro District still handles the budget and management of the District with the day to day operations outsourced to Woodmen. Woodmen Hills also operates other Metro Districts.

Park Maintenance

There are some kind hearted neighbors that have helped clean up, pick up and mow our little park. We had trouble this year from the early rains that prevented our landscaper from effectively spraying for weed control. They tell us that they need 10 days of dry weather for their weed control agent to work. We hope to get a handle on the weeds soon. We also plan to have the Special Districts Association (SDA) conduct another audit of our playground to ensure that it meets standards and identify any issues. One problem that needs help from the community is picking up pet droppings. This is not only a health issue but also can be troublesome for our kids who play in the park.
